

TERMS & CONDITIONS

Pursuant to Section 4513.34 of the Ohio Revised Code, the below-named permittee is hereby authorized to move the vehicles, objects or structures identified herein that are in excess of the weight and/or size maximums specified in sections 5577.01 to 5577.09 of the Revised Code, or otherwise not in conformity with sections 4513.01 to 4513.37 of the Revised Code. Movement is authorized upon the specific streets, highways, bridges or culverts identified herein and the permittee shall be limited to those routes specified and no others. Authorization to traverse bridges/structures owned and/or maintained by entities other than the Sandusky County Commissioners or Township Trustees (in the case of a Township owned/maintained roadway) must be obtained from the proper authorities (e.g. State owned roadways, City or Village roadways and the Ohio Turnpike).

-- Maximum Permitted Speed May Not Exceed 45 MPH. --

This permit may be suspended or revoked by the Sandusky County Engineer or any law enforcement officer for any good cause, including, but not limited to, any violation of the terms, conditions and limitations of this permit, any violation of law, or any lapse or reduction of the required insurance coverages.

This permit shall take effect on the _____ day of _____, 20____, and shall expire on the _____ day of _____, 20____ (or the date of expiration of the required insurance, whichever is earlier; or, in the case of a single move, upon completion of the move).

This permit is subject to all Terms, Conditions and Limitations contained herein. All limitations/provision and special conditions required as part of an ODOT permit issued for the permitted vehicle/load specified in this permit shall be considered requirements of this permit.
